2025 Community Health Needs Assessment and Implementation Strategy Priorities

Trinity Health Lakeshore consists of Trinity Health Muskegon, Trinity Health Shelby, and Trinity Health Grand Haven. A CHNA identifies community assets, needs, and the current state of health and social well-being of a community. The process requires input from community members on identifying and prioritizing the needs to be addressed in the three-year Implementation Strategy. The most significant needs identified for each ministry for FY25-27 CHNA/CHIP include:

Trinity Health Muskegon:

Housing/Homelessness, Childcare, and Access to Healthy and Affordable Food

Trinity Health Shelby:

Housing, Childcare and Health Insurance Coverage

Trinity Health Grand Haven:

Mental Health, Access to Care and Substance Misuse

Community Collaborations & Coalitions

Trinity Health supports eight community health collaboratives with more than 190 members, highlights include:

- Define the Line

Straight Talk About Tough Stuff (STATS):

Since 2001, in partnership with RPHS, Trinity Health has supported STATS in Muskegon County helping students learn about the dangers of substances, the importance of mental health, and resources to help make positive choices.

In 2025, STATS held 40 school presentations in four districts reaching 1,800 students.

Oceana Health Bound in Partnership with

DHD #10: Supported health coach trainers for Healthy Weight & Your Child Program and supported the Village of Shelby & Shelby Public Schools in **\$945,000 grant writing** for Safe Routes to School.

Integrating Clinical and Social Care: In FY25, more than **54,905 patients in primary care settings** and **13,297 inpatients** were screened for social needs and 29% identified at least one need. Top needs included: financial insecurity, food access and social isolation.

Community Resource Directory: 2,475 unique users.

Key Community Initiatives

Community interventions are hospital-based services, programs, and activities that promote health and healing as a response to identified community needs. Some examples of our community interventions include:

Community Health Workers (CHWs): **20** CHWs employed with 2,328 CHW services provided in FY25.

Pharmacy Assistance Program: Served more than **660 patients** with assistance in obtaining more than **4,770 prescriptions** costing more than **\$390,995**.

National Diabetes Prevention Program: Collective weight loss of **more than 856 pounds**.

Patient Social Care Fund: Financial assistance for essential services that address urgent social needs with **\$819 provided**.

Community Outreach: Connected more **than 2,450 people** to social care support.

Trinity Health Muskegon Farm Share & Farm Share Assistance: Distributed **607 Farm Share boxes** and **provided 169 at no cost**.

Produce to Patients: Distributed **3,739 pounds of produce** to patients at no cost with more than **1,414 hours** of community education.
