#### ADDRESS PATIENT SOCIAL NEEDS

#### **Community Interventions**

Community interventions are hospital-based services, programs, and activities that promote health and healing as a response to identified community needs. They increase access to health care addressing social influencers of health (SIOH), improve access to health care services and reduce health disparities within our service areas.

Narcan Vending Machine: Located inside Trinity health Livingston hospital's main lobby, the Narcan vending machine dispenses free Narcan (naloxone) nasal kits to the community. This life-saving medication is crucial in reversing opioid overdoses. The vending machine is available 24/7 to the public.

Community Health Workers (CHW): CHWs serve as a link between health/social services and the community. Their work facilitates access to services that improve the overall health and wellness of the communities they serve. In-patient CHWs screen patients for health-related social needs.

**Patient Social Care Fund:** Provides financial assistance for essential services that address urgent patient social needs.

**Senior Fit:** A program designed to increase the vigor, strength, and balance of the senior community (ages 55+) which reduces the risk of falling and provides a framework for a healthy lifestyle.

**Internship Program:** Provides educational advancement in various administrative and health-related fields through hands-on experience by executing projects.

**Trinity Health Academy:** An educational initiative aimed at bridging the gap between the community and health care through interactive sessions, training and experiences. Sessions are designed to expose participants to hospital programs, engage in meaningful dialogue to foster connections and promote healthier lifestyles

**Community Outreach:** The time our team spends supporting community events and engaging with our community members..
